

The Dunn Family Scholarship Fund Application Guidelines

The **Dunn Family Scholarship Fund** has been established by the children of John L. Dunn in honor and recognition of the bond between the Dunn family and the National Machinery Company and their commitment to post-secondary education. Our grandfather, John E. Dunn began working at the National in 1923 where he served as a foreman and directed the training school. He retired after thirty-four years of dedicated service. When his son, John L. Dunn graduated from college in 1940, John E. encouraged him to apply for a job at the National. After beginning work at the National, John worked on the factory floor and became a foreman, and later served as vice-president of sales retiring in 1985 as senior vice-president.

This scholarship will be awarded to

1. A son or daughter of a current employee of the National Machinery LLC
- or**
2. A Sentinel Career and Technology Center Advanced Placement Program student employed by the National Machinery LLC

who is pursuing a post-secondary degree in the academic year immediately following high school graduation at a two or four year program at the college or university of the student's choice. The student may use the Scholarship for tuition, books or fees.

The recipient will be the person who in the judgment of the scholarship trustees has best demonstrated the same quality of character that John E. and John L. Dunn exemplified while employed at the National. That is namely,

- ✓ Strong work ethic,
- ✓ Vision,
- ✓ Problem solving skills, and
- ✓ Commitment to working at the National Machinery Company.

A scholarship in the amount of \$1000 will be awarded annually.

The scholarship trustees may request interviews of up to three finalists. Each finalist will be notified of a date, place, and time for the interview.

The scholarship committee will consist of a person designated by the National Machinery Company, a board member of the Tiffin Community Foundation, and a Dunn family representative. No information, except that contained in or relating to the application, will be used in the selection process. The scholarship trustees may verify information presented in the application.
