Minutes of Old Fort Local Board of Education Meeting Held July 19, 2018

A motion was made by Mr. Pence to approve the Agenda.

Mrs. Steyer seconded the motion and upon roll call the vote was:
Mr. Pence, Mrs. Steyer, Mr. Bowman, Mrs. Woodall, yes. Motion Carried.

A motion was made by Mr. Pence to accept changes to the 2018-19 Junior High and High School Handbook as presented with the exception of Dress Code changes (p.26 and 27).

Mrs. Steyer seconded the motion and upon roll call the vote was:
Mr. Pence, Mrs. Steyer, Mr. Bowman, Mrs. Woodall, yes. Motion Carried.

A motion was made by Mr. Bowman to accept the following language changes to the dress code: Shorts that are mid-thigh in length while standing and fit properly at the waist or hips.

Mrs. Woodall seconded the motion and upon roll call the vote was:
Mr. Bowman, Mrs. Woodall, Mr. Pence, yes, Mrs. Steyer, no. Motion carried.

A motion was made by Mrs. Steyer to accept the following language changes to the dress code: Sweatpants that are loose fitting.

Mr. Pence seconded the motion and upon roll call the vote was:
Mrs. Steyer, Mr. Pence, Mr. Bowman, Mrs. Woodall, yes. Motion Carried.

A motion was made by Mr. Pence to accept the following language changes to the dress code: Piercings in ears only. (All others must have clear plugs or be covered during school hours and during extracurricular activities)

Mrs. Steyer seconded the motion and upon roll call the vote was:
Mr. Pence, Mrs. Steyer, Mr. Bowman, Mrs. Woodall, yes. Motion Carried.

A motion was made by Mr. Pence to accept the following language changes to the dress code: Leggings, yoga pants, jeggings, or stretch pants that are covered by a skirt or dress that are mid-thigh in length.

Mrs. Woodall seconded the motion and upon roll call the vote was:
Mr. Pence, Mrs. Woodall, Mr. Bowman, yes, Mrs. Steyer, no. Motion carried.

A motion was made by Mr. Pence to remove the word "athletic" from the following language of the unacceptable dress code: Athletic, running, or boxer shorts.

Mrs. Woodall seconded the motion and upon roll call the vote was:
Mrs. Woodall, Mrs. Steyer, yes, Mr. Pence, Mr. Bowman, no. Motion failed.

A motion was made by Mr. Pence to accept the following language changes to the unacceptable dress code: Oversized coats or jackets worn in class.

Mrs. Steyer seconded the motion and upon roll call the vote was:
Mr. Pence, Mrs. Steyer, Mr. Bowman, Mrs. Woodall, yes. Motion Carried.
